New Visas and Nationality service launched

The new UK NARIC Visas and Nationality service launched on 6 April. The UK NARIC website home page now has a new look, with blue and red coloured gateways to the separate online application portals for individuals, one for the familiar UK NARIC statements (blue) and the other for the new Visas and Nationality statements (red) for immigration purposes.

The new Visas and Nationality statements are not replacements for the current UK NARIC Statement of Comparability and English Language Assessment services. The blue and red services will run alongside one another.

For applications for educational courses, or applications for employment, it may be more appropriate to continue to use the current blue UK NARIC statements when proof of qualification comparability or proof of English language level is required.

The new service replaces the Home Office online Points-Based Calculator, which can no longer be used to support immigration and visa applications.

Tier 4 sponsors are largely unaffected by these changes. (more...)

The main venue is the country's Ayb School. The Ayb Foundation is in partnership with Armenia's Ministry of Education and Science to design the new qualification.

The visit is part of UK NARIC's evaluation and benchmarking of the new qualification, which is in pilot phase. The first cohort is set to take final exams in June. (more...)
