**Changes in OISC immigration adviser CPD/training rules**

There are [important changes in the CPD rules](#) for OISC-accredited immigration advisers.

The requirement to do 'core hours' of CPD is removed. However, you must actively consider and identify CPD needs so as to maintain competence, sign and declare to this effect, and maintain records of all CPD activity ready for OISC inspection.

## Information about ENIC and NARIC centres

### ENIC and NARIC centres – Who are we?

Established by the Council of Europe and UNESCO Convention on the Recognition of Qualifications concerning Higher Education in the European Region (the Lisbon Recognition Convention), the ENIC and NARIC Networks are primarily concerned with ensuring that there is a fair and consistent approach to the recognition of qualifications. On that basis the networks operate in an international legal framework supporting the implementation of the Lisbon Recognition Convention as well as the European Union Directives on professional recognition and developing recognition policy and practices for the recognition of qualifications in the European Region.

### What do we look like?

No two centres are the same and not all offer the same services or guidance. Each centre has a unique name that may or may not include 'ENIC' or 'NARIC'. Some have a public office, while others are a small department within another

## New CPQ professional qualifications website is now live

The website for UK NARIC's new [Centre for Professional Qualifications \(CPQ\)](#) is now live and online. The CPQ incorporates the designated 'Assistance Centre' under EU Directive 2013/55/EU on professional qualifications, and replaces the UK National Contact Point for Professional Qualifications (UK NCP) under the older EU Directive 2005/36/EC.
