UK NARIC signs Memorandum of Cooperation with the Association of Arab Universities

UK NARIC and the Association of Arab Universities (AARU) are strengthening their relationship with the signing of a Memorandum of Cooperation on July 14 in London. The document was signed by Dr Sultan Abu-Orabi, Secretary-General of the Association of Arab Universities (*below, left*) and Ian Bassett, Head of UK NARIC Membership Services (*below, right*), representing Dr Cloud Bai-Yun, CEO of UK NARIC.

The AARU is a non-governmental organisation that develops and enhances co-operation between Arabic and Islamic universities and the wider international educational community. An outcome of the agreement will be the launch of UK NARIC training in both Arabic and English for the 340 AARU member universities who teach students across the Middle East and North Africa (MENA) in a geographic band from Mauritania to Oman.

The signing of the agreement represents a new phase of cooperation between the two organisations, to facilitate international education partnership opportunities across the MENA region for UK NARIC members, to help identify and prevent fraud, and to share best practice. ([more...](#))

Erasmus+ study: new tools for international Master's recruiters

UK NARIC Deputy MD Paul Norris presented at the Mastermind Europe conference at the Vrije Universiteit, Amsterdam (*pictured above*), to mark the conclusion of a 3-year Erasmus+ project on how to create internationally diverse cohorts of students for Master's courses.

The project's research suggests that to successfully enrol the right kind of students to their Master's programmes, recruiters must look at the student's experience and aptitudes, as much as their qualifications.
